

REPORT AN AD ON GOOGLE

1. Log into your Google account.
2. Copy the URL of the Ad.
3. Access Google Ad reporting by either clicking on the three gray dots next to the ad in Google, or click or copy and paste the link below in your browser:

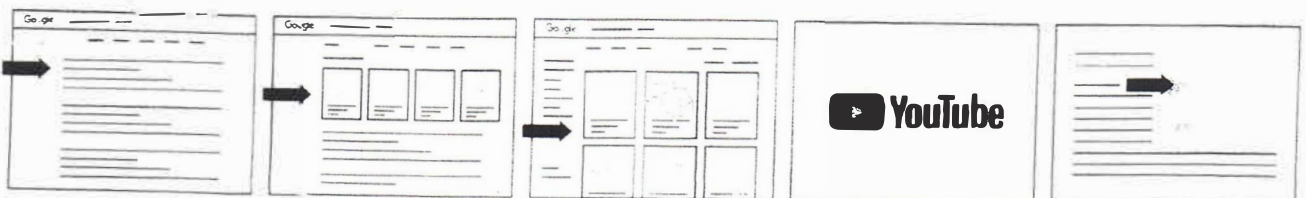

10. Under "Provide Additional Details" state that it is illegal for an agency to advertise in Georgia unless they are a Georgia licensed agency or attorney and that the ad must contain the license number.
